To the evaluator: an opportunity to apply knowledge while analyzing the work of others, increases interpersonal relationships and improves listening skills.

To all other members: valuable lessons are learned for future participation and the overall benefits of an evaluation.

Implementation of evaluations is most notably written or prearranged oral meeting with the evaluator.

In a recent television ad that this president likes, "some ideas come into this world nasty, dirty, and require cleaning up." Good constructive evaluating can provide cleaning up! What do you think?

#### What Does It Take To Pass a Motion?

OAP Parliamentarian, Patricia A. Koch, PRP

You are at a meeting and someone sitting next to you asks "How many people have to vote for this in order for it to pass? Without hesitation you respond! That's because you know that:

If it is an ordinary motion such that the club has a fundraiser next month, a majority vote in the affirmative will adopt the motion.

**Let's be clear** that a majority is "more than half of the votes," not one more than half. (13 people voted—one half of 13 is 6.5). Try to get 7.5 votes!

➤ If it is a bylaw amendment, a vote on the Previous Question, or a vote to Suspend the Rules (and there are other examples), a 2/3 vote in the affirmative will adopt the motion.

Now, surely everyone understands a majority and a 2/3 vote!

#### A majority of what? A 2/3 vote of what?

**Robert's Rules of Order Newly Revised (11**<sup>th</sup> **Edition),** p 400 defines a majority vote (without qualification) as "more that half of the votes cast by persons entitled to vote, excluding blanks or abstentions, at a regular or properly called meeting."

**Robert's Rules of Order Newly Revised (11<sup>th</sup> Edition),** p 401 defines a two-thirds vote (without qualification) as "at least two thirds of the votes cast by persons entitled to vote, excluding blanks or abstentions, at a regular or properly called meeting."

Continuing on page 401 "As a compromise between the **rights of the individual** and the **rights of the assembly**, the principle has been established that a two-thirds vote is required to adopt any motion that: (a) suspends or modifies a rule of order previously adopted; (b) prevents the introduction of a question for consideration; (c) closes, limits, or extends the limits of debate; (d) closes nominations or the polls, or otherwise limits the freedom of nominating or voting; or takes away membership. (Bold emphases are those of this writer.)

#### Bylaws--Be Careful! Read the Words!

Your bylaws state "These bylaws may be amended by a 2/3 vote of the membership."

- If there are 210 members, a vote of 140 in the affirmative will adopt the amendment.
- ➤ But your bylaws require only 24 attendees for a quorum! What to do?
  - Amend your bylaws to state: "by a 2/3 vote of those present and voting."
  - Then, if there are 24 attendees at a meeting, for example, a 2/3 vote would be 16! A whole lot less than 140!

**Read the amendment article in your bylaws.** Does the article need to be amended? Make sure you get more than the required number of people at the meeting in order to get the hoped for amended wording adopted.



#### WAIT! THERE'S AN APP FOR THAT!

I am not recommending any of them as I have not "played" with any. But, you may find them useful. I have an android phone. I am going to assume that you can find these for iTunes as well.

The first is Magic Gavel Basic. It's \$9.99. It claims to help with meeting preparation, running the meeting, motions, ending the meeting and more. And you can toggle between RONR and AIPSC. It covers 30 common motions. Magic Gavel Meeting Tools is included in Magic Gavel Basic.

Magic Gavel Meeting Tools is \$0.99. It is a vote calculator, a quorum calculator and a speaker timer.

Gavel Strike is a free app that is supposed to make the sound of a gavel when you touch the face of the phone. Reviews show it needs improvement.

Ready For The Question is the final app I'll mention. It's \$0.99 and is supposed to rank the motions for you after you put them in and keep you on track when there are amendments and other secondary questions.

I hope you find these apps somewhat entertaining, if not useful. I plan to download a couple myself.

We're continuing our series on the Units in Ohio. It is hoped that each Unit gains ideas from the others that may work for them.

### North Coast Unit of Parliamentarians Patricia A. Koch, PRP President January 30, 2017

- 1. How many members are in your Unit? There are 21 members, 13 provisional unit members and 8 members of NAP, 1 is a RP and 3 are PRPs.
- 2. Does your unit have a formal study curriculum? What is the unit studying? The unit's education is built around the president's yearly theme. 2016 and 2017 have the theme "Better Meetings Make a Difference." The Vice-President is the Education Chairman, as stated in the unit bylaws. The President and Vice President determine the monthly content. Then the VP creates the calendar of lessons (Jan, Feb, March, Apr, May, June, Sept, and Oct.

In 2016 the monthly lessons included: The Order of Business Part 1 (MRSSUN) and The Order of Business Part 2 which included more detail about Reports and Unfinished Business and General Orders, How Committees Function, Preparing and Presenting Committee Reports, and Perfecting the Language of Motions (by the presider) and Perfecting the Language of Motions (by the assembly)

In 2017 the monthly lessons will include the topics: Assemblies and Sessions; Bylaws; Standard Descriptive Characteristics of Motions, the Motion to Refer, the Motion to Lay on the Table, Incidental Motions. Each lesson is followed by group discussion of questions; role playing.

At the final 2016 meeting, members shared that they would like to have time at meetings to share their parliamentary dilemmas/questions and get feedback as to solutions. We are including time at some of the regular meetings when members can pose their questions.

- 3. **If you do have a formal study plan, who teaches?** Teaching of lessons is rotated among the members, Presenters may ask for assistance from the Education Chairman or anyone else.
- 4. If you have electronic meetings all or part of the year, how are they conducted? Is it an email to everyone or do you use any certain online meeting service such as GoToMeeting.com? Or do you have a group Skype or Facetime? We do not conduct unit meetings electronically. However, some of our committees meet by telephone conference call.
- 5. Are you looking for new members? In April, we conduct a Parliamentary Law Month Workshop which is advertised through fliers, person-to-person or person-to-group invitation, newspaper publicity, and two times in the past by television interview. This workshop usually 10-15 guests, 3 presentations by unit members, a question and answer time. The Parliamentary Law Month Committee is a standing committee of the unit and begins planning in January. The event is held at a local library. We invite attendees to our unit meetings.

As to our regular meetings: members invite friends, relatives, fellow members of outside groups. We usually have guests at each of our meetings. We have been very successful in welcoming most of these guests as provisional members.

Our unit stresses preparation for the NAP Membership exam through separate study times (twice a month on a Sunday afternoon) led by Pat Koch, PRP. We use the study guide and RONR in Brief. The sessions are 1 ½ hours, but we usually stay for an extra half hour or more. Already two unit members have passed the test. We also have two other members who recently passed the NAP exam. They studied on their own but did last minute studying with Pat Koch. One of them took and passed RP exam in January. At this time, there are 5 unit members in the NAP Exam study group. We hope two or three more may join. Each person decides on their own when to take the exam.

Several members are studying for the Registered Parliamentarian Examination. Pat Koch invites these members to her home once a month to study together for about two hours. Members work on topics and questions suggested by Pat but bring other questions as well. At this time, one of the members has passed the RP examination. One other plans to take the exam in February.
